2025 PICKLEBALL RULE CHANGES

Rule 6.C.4. Players are not allowed to ask for, or accept, any spectator input.

Rule 4.C.2. When the server starts to call the score, a player on the non-serving team can use "verbal indicators" (such as "stop" and "wait") to tell the serving team they are not ready.

Rules 9.B.1 and 9.H. If your paddle or other clothing touches the non-volley zone (kitchen) before the volley, it is no longer a fault — as long as it's not still touching the kitchen or kitchen line at the time the ball is struck.

Rules 13.D.1.c and 7.0. If there is any disagreement among teams about a called foot fault, a replay shall occur. However, disagreement between partners is not grounds for a replay. The purpose of the change is that, when partners disagree, the benefit of that doubt should go to their opponents.

Rule 13.D.1.a. Allows players to call a fault on their partner.

Rule 2.E.5.c. Allows for autographs on a Pickleball paddle. Currently, the rule only allows pen markings that are for identification purposes (name, signature, phone, email address).

These rule changes are only a few of the dozens of approved rules changes for 2025. View the 2025 USA Pickleball Rulebook at usapickleball.org.
